FACILITATOR LETTER



I was familiar with the purpose of the CEO program but, it was not until I began training with Midland back in August of 2021 that the excitement began to really build.

We began the school year with a group of highly ambitious students. The class decided to create not one but, two businesses! They felt strongly that the drive-in movie hosted by the 2020-2021 CEO class was a highly desired community event and something they should continue.



In order to create two businesses, the student team knew they would need financial support. They were able to secure eight sponsors for the events, All-in-One Real Estate Company, Jordan Hicks Country Financial, Legence Bank, WKI, Beck's Drugs, Eubanks & Daugherty, HMC, and David J. Lane Audiology.

The drive-in movie, "The Santa Clause" was a great success with an estimated over 250 people in attendance. The second class business was a vendor fair entitled "Frosty Fest". This event was held at Little Chapel Church and hosted 24 vendors. It was important to the team that we have a variety of vendors at our event. They sought out and succeeded in bringing in food vendors, clothing vendors, home goods vendors, and more. This event also offered the community free, fun activities for the kids such as a bouncy house, games, crafts, and even Santa! We had a lot more children attend than anticipated. Frosty Fest was another great success with over 500 people in attendance.

Second semester started strong as the class finalized and presented their business ideas to the board for approval. Once approval was given they worked with their mentors to create their business plans to present to local bankers for "Banker Day". Fantastic feedback was provided by the local bankers who participated and the board then delegated what sum of funds should be allotted to each student. In early March the students were given an investment from the board and they were then able to purchase the items needed to launch their businesses.

The Saline County CEO Trade Show was held on April 21, 2022 and was another great success. I was extremely proud of each student. Our goal was to ensure their business products and presentation looked professional and they did a great job ensuring just that!

What an honor it has been to be a part of this program. We currently have 14 students enrolled for the 2022-2023 school year and I look forward to it with great anticipation. Thank you all so much for your continued support.

CREATING ENTREPRENEURIAL OPPORTUNITIES





Kelsie Woodson, a 2016 graduate of Saline County CEO Program, knew that the skills she would learn in CEO would be helpful for her, but she didn't know just how much.

"CEO really changed my perspective. Coming from a small town, there's that mentality of 'I want to leave...' But the community really took the time to listen to us and invest in us. They gave us tips to help us succeed...It really opened my eyes. Today, I see a lot of potential here in my community, so I stuck around."

After graduating from nursing school, Kelsie went to work for an employer she met in CEO saying, "It paved a path for me. The opportunities I have now, I don't know that I would have gotten that without the people around me helping me be a better nurse and a better person."

Today, Kelsie, just a few years out of nursing school, is already the Director of Nursing at an assisted living center in her hometown, managing over 50 people.

"CEO taught me so many things coming into adulthood. It taught me how to talk to people, to reason with them, and even marketing skills - having those skills has really helped me get to where I am today."

Of the importance of the CEO Program, Kelsie says, "Even if you don't want to do business, the skills you learn will follow you whatever you do. I didn't realize how big this world really is and sometimes it takes a community to lead young people and show them to open their minds. Young people just see what's in front of them...but if we can give them the tools and guidance to change, we can show them what's possible."

That's one of the key things Kelsie remembers a community member telling her during her time in the program, "It really stuck with me. They told us that things can't change unless we change them. I think that If we can give our young people the perspective that shows them that they are the key to change, that reflects directly on the community."
